

Official Rules for the 2012 Camaro Convertible 1LT Car Raffle  
**Sponsored by The Center for Enriched Living**

The Center for Enriched Living is a 501(c)(3) charitable organization located in Riverwoods, IL. The Center for Enriched Living (CEL) exists so that people with developmental disabilities can be fully included in the community, achieve personal success, and enjoy a good quality of life.

TICKET PRICE

The purchase price of a single raffle ticket is \$100 each, 3 tickets for \$275 or 6 tickets for \$500. Checks or money orders should be made out to The Center for Enriched Living. A "purchase" shall not occur and be binding on The Center for Enriched Living until funds received for the same have cleared the bank. Credit cards accepted are Discover, Visa, MasterCard and American Express. Ticket purchases are not tax deductible.

Each raffle ticket purchased shall constitute as an "entry" into the raffle, and the person to whom the raffle ticket is registered shall be the "Entrant." Although more than one name may be provided on the ticket registration form, the ticket shall be registered to the first name listed, who shall constitute the sole Entrant for that ticket. The winning Entrant shall be the "winner" of the prize. Payment to or delivery of any prize will be made to the Entrant. The winner must supply his/her social security number before the prize is tendered. It is the sole responsibility of the Entrant to allocate a winning prize to other participants in case of a multiple entry registration, and the winning Entrant shall hold harmless The Center for Enriched Living in case of conflicting claims or disputes among multiple claimants.

QUANTITY OF TICKETS

The maximum number of tickets offered for sale is 899. Requests for ticket purchases (and therefore payments received) after all tickets are sold or following the drawing, will be returned to the buyer(s).

ELIGIBILITY

Purchasers of raffle tickets must be legal residents of the United States and 18 years of age or older on, or before, Monday, March 19, 2012 for the Early Bird Raffle Drawing or on, or before, Monday, April 30, 2012 for the Car Raffle Drawing. The Entrant must supply his/her social security number to receive winning prize. If an Entrant's check or credit card is dishonored prior to the drawing, the entry ticket will be declared invalid, until a replacement is received. All check or credit card charges found declined after the drawing must be honored. A \$30 charge will be assessed for non-sufficient funds or stop payment checks. Void where prohibited by law.

DRAWING

Completed requests must be in the possession of The Center (280 Saunders Road, Riverwoods, IL 60015) by 3:00 PM CST on Friday, April 27, 2012, unless otherwise personally

delivered to an authorized representative of The Center before the time of the drawing. The raffle will take place on, Monday, April 30, 2012 with a random drawing during The Center for Enriched Living's *Chefs' Night & More!* fundraising event held at the Lincolnshire Marriott Resort, Lincolnshire, IL. If not sold out prior to the event, tickets will be available for purchase until the time of the drawing. Purchase of a raffle ticket does not entitle the purchaser entrance to the event. The winner, if not present, will be notified within 7 business days. It is the responsibility of the purchaser to provide a valid, deliverable mailing address, phone and/or email address for notification.

### PRIZES

The winner will have a choice of a 2012 Camaro Convertible 1LT or \$30,000 in cash. Within 14 days from notification, the winner must inform The Center for Enriched Living which prize he/she has selected. All federal, state and local income, sales and/or excise taxes, fees, assessments and like charges associated with the prize, including license, title and registration fees, are the responsibility of the holder of the winning ticket. Winner must complete a W-9 form before receiving prize.

If the winner chooses to take the car as his/her prize, he/she is responsible for picking up the car at Bill Stasek Chevrolet 700 W. Dundee Road, Wheeling, IL 60090.

Entries received prior to March 18, 2012 will be eligible for a \$1,000 cash drawing. The ticket drawn for this prize will be re-entered in the drawing for the grand prize. Prizes are non-transferable.

If fewer than 500 tickets are sold by the drawing on April 30, 2012, The Center for Enriched Living reserves the right to pay one-half of the collected ticket money in lieu of the car or cash prize.

### WAIVER/LIMITATIONS OF LIABILITY

Entrants release The Center for Enriched Living, and its respective board, committee members, officers, volunteers, employees and representative agents from any and all liability with respect to participation in the promotion and possession of the prize.
