



## Housing Settings Current Realities

- Shift away from large state-run institutions
- 75% of adults with IDD live with family and most do **not** receive formal supports or services
- Family caregivers are aging:
  - Over half older than 50
  - 10% 75 or older
  - 1.3 million caregivers over age 60





  - Talk with other families who are creating options


